**Trivia Alert:** On December 19, 1973 late night television host Johnny Carson jokes during his monologue, "You know, we've got all sorts of shortages these days. But have you heard the latest? I'm not kidding. I saw it in the papers. There's a shortage of toilet paper!" **FEMA Stream and Shoreline Stabilization PEA -** The Federal Emergency Management Agency (FEMA) has produced a <u>Programmatic Environmental Assessment (PEA) Stream and</u> <u>Shoreline Stabilization in NY and NJ</u> for public review and comment. The <u>public notice</u> contains the purpose for this PEA, a link to the New Jersey Office of Emergency Management's website and instructions for how to register comments regarding this PEA with FEMA.

**County Flu Shots -** Burlington County Health Department will be hosting Flu Shot Thursdays. Flu shots for adults and teens (13 years and older) are through Drive Thru clinics at various locations throughout the County from 9 am to 11am. Children (6 months to 12 years) are through Walk Up clinics at the Health Department (Westampton) from 2pm to 4 pm. Clinics will run from 9/24/2020 to 1/14/2021 at county locations. Signed consent forms will be required and residents are encouraged to print out and bring the completed <u>Adult</u> and/or <u>Children</u> form with them to the clinics. More information, including locations and schedules, can be found in the <u>detailed notice</u> or <u>brochure</u>. Medicare Part B will be charged and for those without Medicare a \$15 donation is requested if affordable.

**County COVID-19 Test -** Burlington County has a number of COVID-19 test locations. The tests are available to county residents with or without symptoms, no doctors note required. See the <u>COVID-19 Test Flyer</u> for details.
